Item I. Call to Order- Establishment of Quorum

The meeting was called to order at 6:05 p.m. A quorum was established.

The Negotiation Committee members are Mrs. Rummel, Mr. Frassinelli and Mrs. Locke. Ms. Shegogue is an alternate. Mrs. Locke stated that the committees met again last week, and they have three future meetings scheduled.

Item X. New Business

A. <u>Presentation, Discussion and Approval of the Reductions to the 2015-2016 Budget for the Stafford Public Schools</u>

Dr. Collin stated that on February 23, 2015, the Board of Education approved a budget for Stafford Public Schools totaling \$27,822,500 for the 2015-2016 school year. This represented an increase of \$912,705 or 3.39% over the approved budget for 2014-2015. Subsequently, on April 6, 2015, the Board of Finance (BOF) directed the Board of Education to reduce its budget by \$200,000.

Dr. Collin reviewed a detailed spreadsheet, which reflected reductions and adjustments totaling \$200,000 and resulted in a budget totaling \$27,622,500, representing an increase of \$712,805 or 2.65% over the approved budget for 2014-2015. She noted that this detailed spreadsheet will be posted on the district's website (www.stafford.k12.ct.us, under Board of Education > Budget).

Mrs. Locke asked questions regarding the reduction to SRBI supplies / the effect on the interventionist and magnet school tuition.

Mr. Goodell asked if freshman basketball could remain in the budget and some other item be identified for reduction. Dr. Collin stated that because those students have the opportunity to play basketball with the recreation program and because there will still be JV and a varsity team at the high school, she felt that this reduction had the least impact on students.

Mrs. Walsh made a motion, seconded by Mrs. Locke, that the Board of Education approve the revised 2015-2016 budget for Stafford Public Schools in the amount of \$27,622,500 in response to the April 6, 2015, mandate by the Board of Finance, as presented. Mrs. Locke, Mrs. Rummel and Mrs. Walsh voted for the motion. Mr. Goodell voted against the motion. The motion carried by majority vote.

Item VIII. Public Forum

Mrs. Locke made a motion, seconded by Mrs. Walsh, to move this item to follow item X.A.- <u>Presentation</u>, <u>Discussion and Approval of the Reductions to the 2015-2016 Budget for the Stafford Public Schools</u>. Mr. Goodell, Mrs. Locke and Mrs. Walsh voted for the motion, which carried.

A member of the audience stated that she is concerned with the cuts to curriculum, especially in the area of science. She said that the reason the district loses students to magnet schools is because the district's science standards aren't as high. Mr. Bednarz responded that he was able to negotiate with a vendor to provide the science kits at a lower price. He said that some kits would be delayed a bit, but that Stafford is ahead of most districts in this area at this time.

A member of the audience requested more information regarding the amount for which the district is responsible for resident students attending other schools (i.e. magnet, vocational, etc.). Mrs. Marinelli stated that she would forward the information electronically.

Item XI. Personnel Matters

A. Recommendation of Superintendent of Schools Regarding Teacher Non-Renewals

Dr. Collin stated that in her capacity as Superintendent of Schools, she recommends that the Board of Education non-renew the teaching contracts of all non-tenured staff members listed below at the end of the 2014-2015 school year, in accordance with the provisions of Connecticut General Statutes Section 10-151, and that the Board authorize her to furnish written notice of the action.

She said that she is making this recommendation due to possible elimination for budgetary reasons, which she views to be sufficient basis for the recommended action.

The above named teachers have been advised prior to this meeting that Dr. Collin intended to make this recommendation; and, if the Board takes action, the teacher has the right under Connecticut General Statutes Section 10-151 to request the reasons for the Board's action to non-renew his/her contract of employment and that further, depending upon those reasons, may be entitled to a due-process hearing to consider the Board's decision to non-renew the contract of employment.

Dr. Collin said that she also recommends that she be authorized and instructed to communicate notice of this action in writing to the affected party and to respond on behalf of the Board to any appropriate requests, which may be forthcoming from the teacher or his/her representative(s) as provided in the Teacher Tenure Law.

Mr. Goodell made a motion, seconded by Mrs. Walsh, that pursuant to Connecticut General Statutes Section 10-151, the Stafford Board of Education non-renew the teacher contracts of those staff members listed above at the end of the 2014-2015 school year. Mr. Goodell, Mrs. Locke and Mrs. Walsh voted for the motion, which carried.

Mr. Goodell made a motion, seconded by Mrs. Walsh, that Stafford Board of Education direct the Superintendent of Schools to communicate this action of the Board in writing to each of the above named teachers and that the Superintendent of Schools be authorized to respond on behalf of the Board of Education to any requests for a hearing, if required by law, or for other data which may be forthcoming from the teacher and/or his/her representative(s) pursuant to applicable provisions of Connecticut General Statutes Section 10-151; and that the Superintendent of Schools be directed that any response to a request for a hearing, and if a
